## DR. J. M. TWILLEY DEAD.

Dover, Oct. 25.-Dr. Joshua Marion Twilley, Dover's oldest dentist years of practice and age, died yes+ terday. He practiced in Dover for 45 years and was 72 years of age. He died University of Pennsylvania Hospital, Philadelphia, having been operated on last Saturday for stomach trouble. He was visited Sunday by Dover citizens and was reported doing as well as could be expected. His remains were brought here last evening to his home on State street, from which place the funeral will take place tomorrow afternoon at 2 o'clock. Interment will be made in Christ P. E. Churchyard, this town, Dr. Twilley is survived by a widow, a second wife, the first wife who was a Miss Reed. daughter of the late Elias Reed, having died some years ago.
