Dr. Stanley Worden

Funeral services for Dr. Stanley Worden, former Baltimorean who had practiced medicine in Dover, Del., for the last twenty years, will be held at 3 P.M. tomorrow in Christ Church, Dover.

Dr. Worden, who was 53, died suddenly Tuesday of a heart attack while driving through Pittsburgh. He had come to Johns Hopkins Hospital last week for a physical examination.

Born in Baltimore, Dr. Worden attended Johns Hopkins University and served in the Hopkins unit of the World War I United States Army Ambulance Corps. He graduated from the Hopkins medical school and for several years was chief medical physician at the Church Home and Infirmary.

He was active in little theater groups.

In addition to his wife, the former Miss Victoria Vaiden, of Baltimore, he is survived by two children, Stanley Worden, Jr., and Tertia Worden.
