DOVER, Del., April 3—Two very brilliant weddings were solemnized in Christ Protestant Episcopal Church yesterday afternoon and evening. Rev. L. W. Gibson officiated at both. The first was that of Miss Clara Ross to Jefferson L. Ford at 2 30 o'clock. The bride was becomingly attired in a handsome light tar-colored traveling dress. The church was well filled. The couple left on the next train for an extended wedding tour.
