DOVER — Cecil C. Fulton Jr., 82, died at his home, 102 S. State St., after a long illness.

Mr. Fulton, a native of Dover, was a former member of Gilbert C. White Co., engineering consultants of Durham, N.C., and was a retired first vice president of The Home Life Insurance Co. of New York City.

A graduate of the University of Delaware, he was a member of Kappa Alpha fraternity and Union Lodge No. 7 AF & AM, Dover.

He is survived by his widow, Mrs. Louise Cole Fulton; a daughter, Mrs. William P. Richardson, Dover, and a grandson.
