Unclear if she was related in some way to Charles D Pepper. Charles was single in the 1910 US census. He may have been a border in her parents' home, and a drinking buddy of Anie's father.

Christ Church burial records indicate death on Jan. 31, 1923 with burial on Feb. 3, 1923. Christ Church is listed on the death certificate below.

A birth certificate for one of Annie Garton's possible children (Herman Carrow Garton) lists mother as Annie Matthews Garton. Belle Greenwood had a sister born in 1862 named Roberta A. Matthews.

Francis P. Matthews (1820-) and Matilda G Matthews (1830-) were the parents of Belle Greenwood, and are listed on this death certificate of Annie Garton
