## MRS. LUCY T. HARRISON DEAD IN JOHNSTOWN, PA.

Mrs. Lucy Turner (Vinson) Harrison died Wednesday, May 9, at 3 p. m., at the home of her daughter, Lucy, 907 Ash street, Johnstown, Pa. was in her 66th year. Her health had been impaired for some time, but she died very unexpectedly, due to heart failure. Her illness was not considered serious, so her death was a shock to her family and friends.
