Each of the crew testified that the proper signals were given by blowing the whistle and ringing the bell. Engineer Russell said he saw the automobile on approaching the crossing but by the time he had applied brakes and used other means, it was too late, the engine striking the machine and hurling it with the body over on the southbound tracks. He said he was running between 45 and 50 miles per hour and that his train, at was three minutes late. The verdiet 50 follows:

INQUEST IS HELD IN JUSTIS' DEATH

Jury Unable to Find Explanation for Tragedy at Wyoming.

(Special to Every Evening) Dover, September 8.—Coroner W. D. Eanls yesterday summoned a jury to investigate the death of Cleveland Justis of the State Highway Department, who was killed last Saturday morning at the Saxon crossing south of Wyoming, when struck the 8.37 express train over the Delaware railroad, Howard M. Buckson, cashier at the

Peoples Trust Company was selected as foreman of the jury and Herman C. Taylor, secretary. The crew of the train included

George Tumlin, conductor;

Russell, engineer; Preeman S. Holland, fireman; C. T. Harrington, baggage master; C. S. Cortelyou, flagman, I. Paul Jones, secretary of the State Highway Commission was also summoned.

that the proper signals were given by blowing the whistle and ringing the bell, the engineer stating that he saw the automobile before approaching the crossing, but by the time he had applied the brakes he saw it was too late, the engine striking the automobile and hurling it, with the

body, over to the south bound tracks. The engineer also stated that he was running between 45 and 50 miles per hour and that his train was 2 minutes late.

The testimony of the other witnesses dealt with the finding of the picking it up and bringing it to Wyoming.

The jury after deliberating for a

short while rendered the verdict that Cleveland Justis came to his death by being struck by train 456 on Saturday morning, September 5, 1925, at Saxon's crossing, south of Wyoming.

After the inquest the casket conwas removed to his late home on Academy Square into which had moved last week. Later in the afternoon it was taken to Christ P. E. Church where services were held, by Rev. B. F. Thompson, rector of Christ Church, interment being made in the churchyard adjoining.

About the Cleveland Justis Family:

His widow, *Jessie Vincent Birnbach Justis* (1893-1965) moved to Haddon Heights, New Jersey with her two young children and her mother sometime after 1927. Her mother, Hannah Emily Wolfe Birnbach died at her daughter's home 8 January 1930 and was buried in the Christ Episcopal Church Cemetery, Dover, Delaware. On 24 February 1932, Jessie Vincent Birnbach Justis married another widower, John Young Floyd and continued to live in Haddon Heights, New jersey. Her husband John Young Floyd (1877 – unknown) is assumed buried with his second wife Addie Mae Zanzenberg Floyd (1885-1928) in Fernwood, Delaware, Pennsylvania. His date of death was not inscribed on the grave marker. In November 1957, Jessie Vincent Birnbach Justis Floyd returned the three remaining plots (B, C, and D) in the cemetery back to Christ Church, Dover, Delaware. Jessie Vincent Birnbach Floyd went to live near her daughter, *Emily Elizabeth Justis Allen* in Orange County, California. She died on 21 January 1965 in Orange County, California.

Cleveland Justis' son, *Robert Young Justis* (1918-2000) was and electrical engineer and inn keeper in Stowe, Vermont. He had two sons, *Robert Young Justis*, *Jr* (1943-2021) and *Cleveland Tabler Justis* (1968 -). Robert Young Justis is buried in the Grace and St. Stephens Episcopal Church Columbarium in Colorado Springs, El Paso, Colorado, USA.

Cleveland Justis' daughter, *Emily Elizabeth Justis* (1923-2012) married her high school sweetheart, *Jacques Hartley Allen* (1923-1945) In 1943. Tragically, her husband died of his injuries suffered in World War II. He never met his daughter, *Kathleen Emily Allen* (1946 -). In 1946, *Emily Elizabeth Justis Allen* married *Robert Wesley Allen* (1922-2008) and they had two daughters, *Beverly Allen* (1953-) and *Janet Allen* (1955). The couple spent most of their married life in Orange County, California. In 2002, the couple moved to Loveland Colorado. She and her husband, Robert Wesley Allen were cremated and their remains are in the All Saints Episcopal Church Columbarium, in Loveland, Larimer, Colorado, USA.


