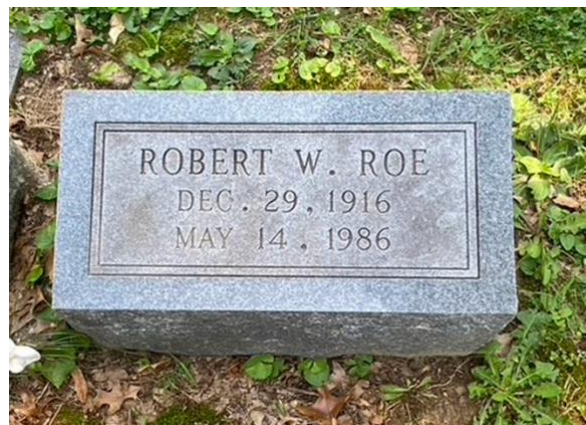

DOVER — Robert W. Roe, 69, of 832 Sunset Terrace, died of pneumonia and kidney failure Wednesday in Kent General Hospital.

Mr. Roe worked for the state Division of Highways for 20 years. He retired in 1979 as personnel director and purchasing agent.

An Army veteran of World War II, Mr. Roe was a past commander of the DelVets. He was a member of Christ Episcopal Church. He served as president of the Dover Junior Chamber of Commerce in the early 1940s

Surviving are his wife, the former Margaret Steele; three daughters, Nancy R. Ahern of Rehoboth Beach, Rebecca R. Brewer of Dover and Margaret R. Brauer of Poquoson, Va.; two sisters, Dorothy McFadden of Salinas, Calif., and Helen Turner of Frederick, Md.; and five grandchildren.

Services will be at 11 a.m. Saturday in Christ Episcopal Church, State and Water streets. There will be no viewing. Burial will be in the adjoining churchyard.
